



ADPOL GB, LTD. WARRANTY

Terms and Conditions

ADPOL GB, LTD. warrants to the original purchaser that all of its products shall be free from defects in material or workmanship for the periods specified below. This warranty applies to the products under normal use, subject to the conditions herein, and as determined by ADPOL GB, LTD. in its sole discretion. This warranty does not cover damages attributable to improper installation, inadequate maintenance, improper product use, after market product modifications, normal weathering, highly corrosive environments, damages caused by fire, accident, food, acts of God, vandalism, building settlement or structure failures, or other occurrences beyond ADPOL GB, LTD. control.

ADPOL GB, LTD.'s liability under this warranty is limited to repair replacement or refund as determined by ADPOL GB, LTD. in its sole discretion.

This warranty applies to the original purchaser of ADPOL GB, LTD. products in the home or structure where originally installed and only within the U.E.

Structural Integrity of Windows and Doors

All wooden-aluminium framing constructions have a ten (10) years manufacturer's warranty.

All wooden framing constructions, glass and aluminium covers have a five (5) years manufacturer's warranty.

All oil painted woodwork has a one (1) year manufacturer's warranty.

All wooden inside and outside door constructions have a three (3) years manufacturer's warranty.

All accessories installed in woodwork, such as locks, handles, etc.) have a one (1) year manufacturer's warranty.

All windowsills and window blinds have a one (1) year manufacturer's warranty.

All winter gardens, conservatories and elevations have a three (3) years manufacturer's warranty.

Glass

All glass has a five (5) years manufacturer's warranty from delivery under normal conditions of use, that the products shall be free of defects resulting in material edge separation or obstruction or heat strengthening process, are to be expected and are not covered under this warranty.

Paint Finish

All RAL wood finish and all dark translucent wood finish have a five (5) year manufacturer's warranty.

All light translucent wood finish has a three (3) year manufacturer's warranty.

ADPOL GB, LTD. paint finish warranties described herein do not cover scratches, weathering or products that are not properly maintained as provided for in this warranty. ALL PRODUCTS MUST BE PROPERLY PROTECTED DURING INSTALLATION, INSTALLED BY TRAINED ADPOL GB, LTD. INSTALLERS AND MAINTAINED AND CLEANED IN ACCORDANCE WITH THE WARRANTY.

Where to Make a Claim

General Provisions

This Warranty covers only those manufacturing and material defects as specified herein and does not include defects or damage caused by installation, accidents, fire, flood, hail or other Acts of God, extraordinary impact, vandalism, riot or civil disorder, misuse, abuse, harmful fumes, vapors or chemical pollutants in the atmosphere, mildew, building settlement or structural failure of walls or foundations.

THIS WARRANTY IS LIMITED TO THE REPAIRING OR REPLACEMENT OF DEFECTIVE PART OR COMPONENTS AND DOES NOT COVER OR INCLUDE ANY LABOR COSTS. ADPOL GB, LTD. WILL NOT BE RESPONSIBLE FOR ANY COSTS INCURRED IN THE REMOVAL OR REINSTALLATION OF THE WINDOW OR DOOR OR ANY PART OR COMPONENT OF THE WINDOW OR DOOR. THIS WARRANTY DOES NOT COVER BREAKAGE OF GLASS OR TORN SCREENING FROM ANY CAUSE.

THIS WARRANTY IS MADE IN LIEU OF ALL OTHER EXPRESSED OR IMPLIED WARRANTIES AND EXTENDS ONLY TO THE ORIGINAL CONSUMER. IN NO EVENT SHALL ADPOL GB, LTD. BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND, OR RESULTING FROM ANY DEFECTS, OR FOR ANY DELAYS IN PERFORMANCE OF THIS WARRANTY DUE TO CIRCUMSTANCES BEYOND ITS CONTROL.
